- Tuition is due and payable in advance (by midnight on Friday) for services to be rendered to receive an early pay discount of \$3 per day per child. The base tuition is due beginning at 12:01 am Saturday and thereafter without discount. Discount will be reflected on your bill for the following week.							
- A late fee of <b>5%</b> is due if tuition is not received by midnight on Wednesday during the week that services are provided and will be applied to the entire balance due as of Thursday at 12:01 am. This fee will be added to your bill the following week.							
- Tuition is not subject to any credits for holidays, emergency closures (i.e. weather) or absence other than hospitalization, contagious illness or absence at the request of a doctor (a written doctor's note is required for a credit to be posted).							
- I agree to pay the full tuition fee even if my child is absent for one or more days.							
- A non-refundable registration fee of <b>\$60</b> is due upon enrollment.							
- A late pick-up fee of <b>\$1.00</b> per minute per child is due if my child is not picked up before closing.							
- If tuition is not paid by the end of the week of service, I understand that my child may not be permitted to return the following week and a face to face meeting between both parents and the board may be required.							
- All NSF checks or returned online transactions will be charged a fee of \$25. Two or more returned payments will result in my account being placed on a "cash or money order only" payment status.
